TO WATCH OR LISTEN TO THE VIRTUAL PUBLIC MEETING

- **To listen to the meeting (in listen-only mode) using your telephone:** Dial **646-558-8656** then input the Meeting ID: **851 2114 8678**, followed by #. There is no participant ID. Press # again. You will automatically be placed on mute and will hear a recorded message advising that if you wish to speak, you should press *9 and the host will be alerted. To provide a public comment, press *9 and see additional instructions below.

TO SPEAK AND PROVIDE PUBLIC COMMENTS DURING THE VIRTUAL PUBLIC MEETING

Dial 646-558-8656 then input the Meeting ID: **851 2114 8678**, followed by #.
There is no participant ID. Press # again.

You will automatically be placed on mute and will hear a recorded message advising that if you wish to speak, you should press *9 and the host will be alerted. This is known as "raising your hand."

When the Chair of the meeting recognizes you and calls upon you to speak (identifying you by your name or the last 4-digits of your telephone number), the host will "unmute" you and you will hear a recorded message advising you to press *6 to unmute yourself.

You should press *6 on your phone to unmute yourself.

Once you are unmuted, you may proceed to deliver your comments.

Please provide the following information before delivering your comments: Your Name, Address, and if you are engaged in Lobbying Activities and/or representing an organization.

Please be sure to be in a quiet area to avoid unnecessary noise.

A time limit may be imposed for each speaker during public comment.

Your cooperation is appreciated in observing the time limit.

At the discretion of the District Board, public comments received via email may be read into the record during the public comment portion of the agenda, if any.
